

## INSTRUCTIONS REGARDING DOCUMENT VERIFICATION (ITI)

A. All shortlisted candidates are requested to report at **the Venue provided against their Name(s) on 15<sup>th</sup> April, 2026 (10:00 AM)** along with original and Self- Attested copies of following:

- The matriculation certificate and detailed mark sheet.
- Provisional/ original ITI certificate clearly indicating the Discipline in which ITI Certificate has been acquired; the marks obtained (in aggregate) along with maximum marks, the percentage as given by Institute, and the duration of ITI Course along with the years specified.
- Himachali/ HP State Domicile certificate, Category certificate on prescribed formats in case of SC, ST, OBC & PwBD candidates. The OBC (NCL)/EWS Certificate should be issued on or after 01.04.2025).
- The candidates belonging to Project Affected Families and Project Affected Areas (Panchayat) will have to forward the certificate duly issued by the Revenue Officer/Competent Authority to issue such certificates and verified by concerned SJVN Project Office.

B. Also, you will have to bring following documents which have been attached with the email sent to the candidate at the respective email IDs as provided by them at the time of online registration:

- Personal Resume duly completed with latest colored photograph affixed.
- Duly signed Declaration that you have not already undergone one year apprenticeship training or have been employed for duration of one-year or more after the completion of Prescribed course.

C. Traveling allowance for single to and fro journey performed by Class II Train/ Ordinary bus of shortest route shall be paid to all eligible candidates who have been called to attend the document verification. **No traveling allowance will be paid to Ineligible Candidates.**

D. It is also informed that you are being shortlisted subject to meeting the advertised eligibility criteria and verification of documents/facts. **Please note that if the gap between the declaration of result of Prescribed ITI Course and the commencement of training is more than Five years, the candidate will be declared not eligible.**

E. In your own interest, you are advised to ensure that you fulfill the prescribed eligibility criteria as per the advertisement for the document verification. Kindly note that this letter is only a provisional letter for document verification and does not constitute an offer of engagement/training and if selected, this training will be only for one year from the start of training. No extension in training or any employment will be given after completion of one year training by SJVN.
